<p>Out of 3 (three) tenderers Sl. No. M/S Paradise Traders-Md. Shajahan Ali-Mbshiur Rahman Chowdhury (Joint Venture) who quoted the rate 10% below of estimated cost failed to submit rate analysis (rate analysis was sought but not submitted), as such this tenderer is declared non-responsive by TEC as per ITT clause 25(20) and also Ministry of RTHD's condition no. 13 of memo no. 35.00.0000.015.14.050.16-471 dated 17.09.2017 . After scrutiny all document rest 2 (two) tenderers RAB-RC (PVT) LIMITED and Mr Habibul Alam &amp; Mr Shariful Alam JV. are found to be responsive tenderer of which RAB-RC (PVT) LIMITED is the lowest evaluated responsive tenderer.</p> <p>So the rate of RAB-RC (PVT) LIMITED is here by recommended by TEC for awarding contract.</p> <p>It can be mentioned here that though External member of TEC Md. Golam Mostafa agreed and signed all the four stages of evaluation (TER 1, TER 2 TER 3 &amp; TER 4) and unanimously recommended for RAB-RC (PVT) LIMITED for awarding contract, but he is not agree to sign hard copies of Evaluation sheets as he mentions that he differs with ITT clause 25(20) and also Ministry of RTHD's condition no. 13 of memo no. 35.00.0000.015.14.050.16-471 dated 17.09.2017 where there is a condition to submit rate analysis if the quoted rate is more than 5% less of estimated cost and he has given a note of dissent (attached) on hard copy (but agreed in e-GP) on 01.01.2018 about 1 (one) month latter after signing evaluation report 4 in e-GP.</p> <p>But Chairperson &amp; Member Secretary are agreed and signed for awarding contract in favour of RAB-RC (PVT) LIMITED.</p>
