CONSTRUCTION LTD. failed to fulfill the requirement for DBS Base / Wearing Course & 8) M/S. M.A. ENGINEERING - S. Ananta Bikash Tripura & M/S. Shahid Brothers (JV) Failed to fulfill the requirement for DBS Base / Wearing Course & Aggregate Base Type-1 as asmentioned in TDS, so these tenderer are declared non-responsive by TEC and rest 5 (five) tenderers who fulfill all the requirement of TDS and submitted rate analysis are found responsive by TEC & who quoted the same lowest rate. So these five tenderers are applied evaluation factor as set in ITT Clause 44.2 and it is found that 1) MD. MOYENUDDIN (BASHI), Scoured 130.55, 3) SHAMIM ENTERPRISE (PVT) LTD. Scoured 80.33, 5) Mir Habibul Alam & Mir Shariful Alam JV. Scoured 81.79, 6) Ataur Rahman Khan Ltd & Mahabub Brothers (Pvt) Ltd JV. Scoured 197.75, & 7) RAB-RC (PVT) LIMITEDPTSL-MAITREE (PVT) LTD-M/S Saleh Ahmed (JV) Scoured 328.82, So the rate of RAB-RC (PVT) LIMITED-PTSL MAITREE (PVT) LTD-M/S Saleh Ahmed (JV) who scoured highest point of 328.82 is here by unanimously recommended by TEC for awarding contract.."
