

- He shall not be allowed to change or upgrade the approved course/program;
- He shall be required to execute a bond with the competent authority before his departure;
- Upon completion of the course, he shall submit a report in the prescribed format to the Road Transport and Highways Division; and
- After completion of the deputation period, he shall report back to the Road Transport and Highways Division.
