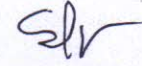
Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in favour of Mr. Chandan Kumar Dey, Deputy Secretary, Roads Division, Ministry of Communication, Bangladesh Secretariat, Dhaka to attend Finalization workshop of the BTILS Updating and Enhancement New Delhi, 14-15 July, 2014. - (h) All expenses in this connection will be borne by the Asian Development Bank;
- (i) He will draw his pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- (j) He will leave for India on 13 July 2014 or nearest suitable date and return from New Delhi to Dhaka on 16 July 2014 or nearest suitable date;
- (k) He will submit a report on the Workshop to the Roads Division, Ministry of Communication within seven days of his return from abroad.
- (l) He will not be allowed to stay abroad more than the approval period.

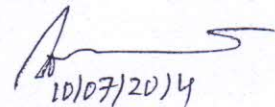
