Sub: Government Order

The undersigned is directed to convey the sanction of the Government of Bangladesh in favor of Mr. Md. 02. Terms and Conditions:

- (a) He will start his journey for Sweden on 18 February 2020 or nearer date
- (b) He will be treated as on duty during the period of the conference
- (c) All expenses in the connection of the conference will be borne by Bloomberg Philanthropies
- (d) He will draw his pay and allowances in local currency; no part of it shall be drawn in foreign currency
- (e) He will have to submit a report on the conference to Road Transport and Highways Division within 5 days after his return.

03. Beside, Mr. Md. Abdul Malek, Additional Secretary will consume additional 5 (five) days post conference with his relatives in Sweden as an ex-Bangladesh leave. During his additional stay in Sweden he will bear his entire expenses from his own. He will return to Bangladesh on 25 February 2019 or nearer date after consuming entire leave in Sweden. He will not be allowed to stay abroad more than the approved period.
