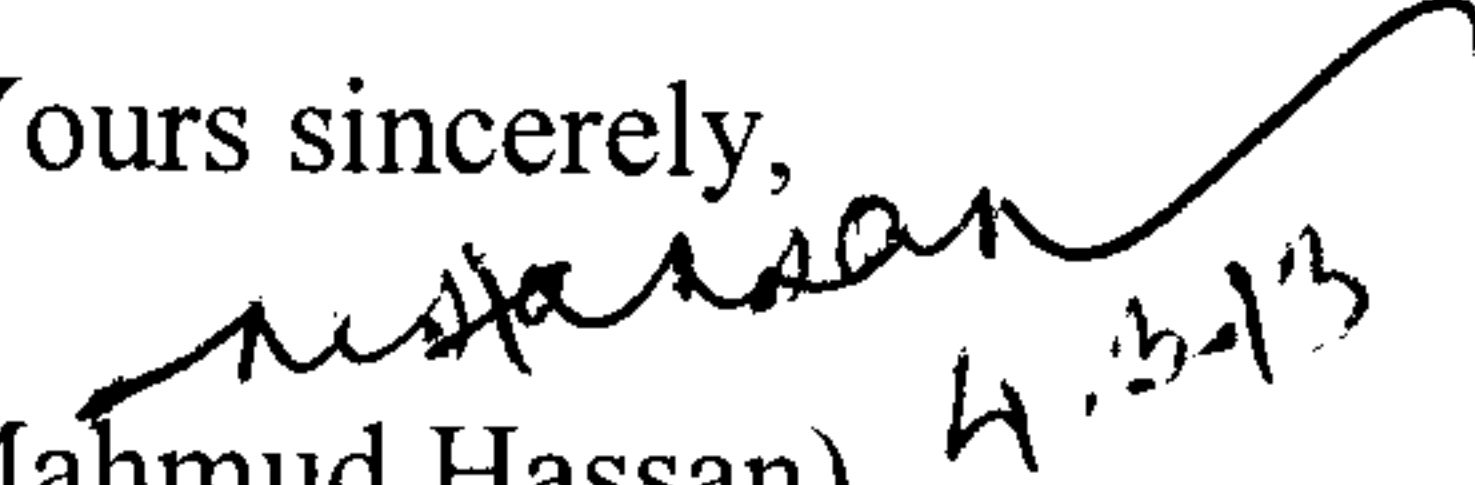
Sir,

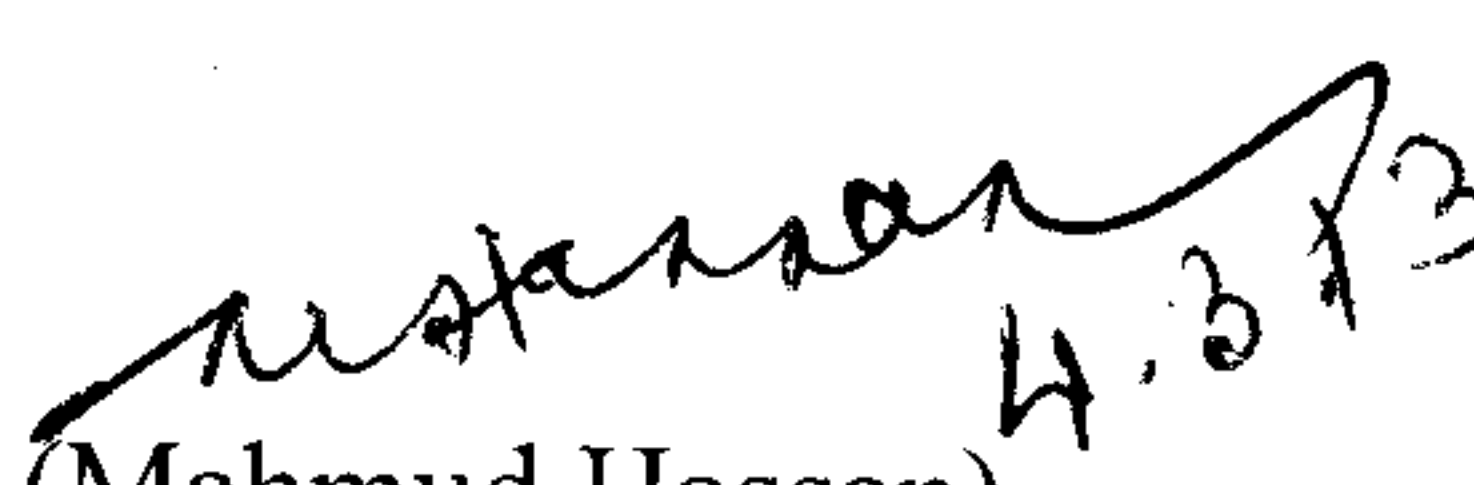
