Government Order

- (d) He will leave for Japan on 07 September 2014 or nearest suitable date and return to Dhaka on 26 October 2014 or nearest suitable date;
- (e) He will submit a report on group training course to the Roads Division, Ministry of Communication within seven days of his return from abroad
- (f) He will not be allowed to stay abroad more than the approval period.

This order is issued with approval of the competent authority.


